**Policies:**

**Bookings:** To secure a date, a signed bridal contract and non-refundable security deposit of 50% of services being booked are required. The deposit will be put towards the total cost of services booked for wedding date. The remaining balance will be due on or before the date of the event. Accepted forms of payment include: Cash, Check, Money Order, Venmo, and all Major Credit Cards/ Debit Cards can be accepted over the phone or by invoice.

**Delays:** We schedule artists to arrive/start services based on the finish time you've scheduled. A late Fee of \$25 .00 will be added for any members of the bridal party that are more than 15 minutes late for their scheduled appointment time. An additional \$75 per hour per makeup artist will also be charged, if scheduled makeup exceeds the scheduled finish time due to client delay.

**Satisfaction Guaranteed:** Makeup will be done to client's satisfaction, our artists will always ask if anyone wishes to change anything before setting the makeup application, acceptance of completed look is acknowledgement that makeup is done to client's satisfaction. Trials are offered if anyone wishes to pre-view their day of look.

**Liability:** All makeup brushes, tools, applicators are sanitized between every makeup application. Makeup products used are high-end and hypoallergenic. Any allergies and/or skin conditions should be reported prior to makeup application, if needed a sample test of makeup can be performed on the skin to test reaction. Client(s) agree to release Powder Studio LLC and their Makeup artists from liability for any skin complications due to allergic reactions.

**Payment:** The final balance will be due on or before the day of the wedding before makeup artist or bridal departure, no exceptions. The responsibility of the remaining balance is the person(s) whose name appears on this contract. Payments can be made through an invoice, with a check, cash, money order, or Venmo.

**Cancellations:** Cancellations must be made at least 30 days prior to the wedding date. Any Cancellations made within 30 days of the wedding date will result in the named party to be responsible for paying the full amount of services agreed upon in this contract. The non-fundable Deposit will not be refunded or credited back for any services that are cancelled after booking.

**Artist Substitutions:** In the event that an artist cannot perform services on the date, another artist will be substituted. A complimentary trial will be offered, if you have already had a trial with another artist that is available on the Wedding date.

**Photography:** We, the undersigned, hereby grant Powder Studio LLC and their Artists to publish, without charge, any pictures taken at our wedding. These photographs may be used on [www.powderstudioia.com](http://www.powderstudioia.com) or other social media for promotional purposes only.
